## Job Summary

The Crane Operator is responsible for the safe and effective operation of cranes and mobile equipment up to 200 tons.

## Duties and Responsibilities

### Technical Competencies

- Ability to read load charts, lifting drawings, understands load distribution, center of gravity and rigging apparel.
- Understanding the crane functions and limitations as well as outside environmental conditions (example wind speed gust)
- Experience in crane inspection ensure that rigging applications are configured in accordance with the lift plans, load chart and manufacturer guidelines.
- Familiarity with all applicable safety regulations, company policies, and safety operating procedures.
- A license issue by government accredited crane operating testing organization.
- Recertification renewal occurs every two years as per internal policy and includes physical examination.

### Tools use Competencies

- Operate all various cranes and equipment types and move materials to various locations in a safe and effective manner.
- Operates any crane controls such as pedals, levers and buttons to regulate speed and direction of crane and hoist movement in accordance to written, verbal and/or signal instructions.
- Perform daily safety checks to ensure equipment is in safe operating condition.
- Complete necessary documentation and reporting.
- Observes load hookup and determines safety level of load.
- Inspect, clean, and perform operator level maintenance on equipment in accordance with standards.

### Other Qualifications

- Responsible for its own work quality, both lifting and rigging, including equipment inspection.
- Understand and follow HSE specific safety rules for the intended application.
- Contribute fully to the team effort to maintain 5S, workstation cleanliness organization.
- Perform any other duties as assigned.

**Additional duties and responsibilities may be added to this position as required by the organization.**
