Job Summary

The Mobile Equipment Operator is responsible for the safe and effective operation of heavy mobile equipment.

Duties and Responsibilities

Technical Competencies

- Ability to understand load distribution, center of gravity and rigging apparel.
- Understanding the equipment functions and limitations as well as outside environmental conditions (uneven terrain, slippery conditions, etc.)
- Experience in equipment inspection to ensure that rigging applications are configured in accordance with the moving plans, equipment load chart and manufacturer guidelines.
- Familiarity with all applicable safety regulations, company policies, and safety operating procedures.
- A license issue by internal company accreditation is required.
- Recertification occurs every year as per internal policy.

Tools use Competencies

- Operate all various heavy mobile equipment type and move materials to various locations in a safe and effective manner.
- Operates any equipment controls such as pedals, levers and buttons to regulate speed and direction of the equipment in accordance to written, verbal and/or signal instructions.
- Perform daily safety checks to ensure equipment is in safe operating condition.
- Complete necessary documentation and reporting.
- Observes load distribution and determines safety level of load.
- Inspect, clean, and perform operator level maintenance on equipment in accordance with standards.

Other Qualifications

- Responsible for its own work quality, both lifting and rigging, including equipment inspection.
- Understand and follow HSE specific safety rules for the intended application.
- Contribute fully to the team effort to maintain 5S, workstation cleanliness organization.
- Perform any other duties as assigned.

Additional duties and responsibilities may be added to this position as required by the organization.
