Job Summary

Responsible for assembly, modification and dismantling scaffolding structures that allow workers to access specific portion of a construction to perform needed work. Taking corrective action to prevent job hazards and keep their team safe from injuries.

Duties and Responsibilities

Technical Competencies

- Pass the test for scaffold builder III level.
- Basic knowledge in scaffolding systems, to build safe scaffolding that stays connected to a large buildings or structures.
- Basic knowledge with federal safety requirements concerning the erection and disassembly of scaffolds.
- Good understanding of all elements in a scaffolding systems like, cross braces, ladders, planks, and guardrails that allow others to work at various heights.
- Basic knowledge in building up and taking down all non hanging types of scaffolds and temporary structures.
- Ability to perform daily visual inspections and light maintenance for simple scaffold systems to guarantee that equipment is working properly under supervision.
- Basic math calculations to determine safe weight loads and interpret blueprints.
- Familiarity with crane operations, must skillfully execute hand signals safely for load and unload scaffold materials using equipment such as slings and cables.

Tool use competencies

- Handling of portable power and hand tools (hammers, ratchets, power drills and hammer drills, levels, cutting wires).
- Proper utilization of HSE scaffold related equipment like hardhesses, safety lines, body vests, etc.

Other qualifications

- Working in extreme weather conditions, stand or walk for long periods of time, climb, stoop, crouch and crawl in restricted spaces.
- Understand and follow HSE specific safety rules for the intended application.
- Contribute fully to the team effort to maintain 5S, workstation cleanliness organization.
- Perform any other duties as assigned.

Additional duties and responsibilities may be added to this position as required by the organization.
